PARENT/LEGAL GUARDIAN CODE of CONDUCT AGREEMENT

As a parent/legal guardian of a child involved with Yucaipa Youth Basketball, I agree to abide by and follow these rules and guidelines:

1. I will promote the emotional and physical well-being of the athletes ahead of my personal desire to win.
2. I will remember that my child plays basketball for his/her enjoyment, not mine
3. I will encourage good sportsmanship through my actions by demonstrating positive support for all players, coaches and officials.
4. I will support my team and players in a positive way.
5. I will provide support for coaches and officials working with the athletes to provide a positive experience for all.
6. I will demand that my athlete treat all players, coaches, officials, parents and spectators with respect regardless of race, creed, color, sex or ability.
7. I will treat all players, coaches, officials, parents and spectators with dignity. I will not use improper language, poor attitude, behavior, or mannerisms.
8. I will not use profanity or rude gestures towards either the opposing team, their coaches, their fans, and the referees, I understand that it is strictly prohibited by the League.
9. I will cheer for my child and his/her team and allow the coach to do his/her job of coaching.
10. I understand that making physical contact or threat with any coach, player, game official, parent, spectator or league or city official will result in my immediate expulsion from the League; I also understand that the incident will then be forwarded to the San Bernardino County Sheriffs Office.
11. I will not enter the playing area without permission of the referee and my athlete's coach. To do so will be a violation of League rules and could lead to possible expulsion from League.
12. If I have a problem with my athlete's Coach, I will address my concerns with him/her first. If the problem is not resolved to my satisfaction, I will make a WRITTEN request to have the Yucaipa Youth Basketball Board of Directors address my concerns.
13. I will not taunt any player, coach or official.
14. I understand, as a spectator, I can and will be ejected /removed from the gymnasium, in the event my behavior is determined to be unacceptable by the Referees or League officials.
15. Harassment of the Referees will result in a technical foul for your team and your removal from the gymnasium. Any Parent or Spectator that is removed/ejected from the gym will be placed on suspension until they meet with the League Disciplinary Committee, who will determine what, if any, further actions may be imposed for their improper behavior.
16. I understand that my participation in Yucaipa Youth Basketball is a privilege and not a right. I also understand that Yucaipa Youth Basketball reserves the right to refuse anyone's participation in their League.

I understand that by signing this document, I am agreeing to support and promote this parent/legal guardian Code of Conduct Agreement. Further, my failure to comply with this Agreement, or my participation in any defined conduct subject to discipline, will result in disciplinary action, up to, and including, expulsion from The Yucaipa Youth Basketball League.
